Cawthorn is passionate about sharing her story and the realities of aging out of foster care so others can learn how to make a difference in the lives of children and youth in foster care. She lives in Rockwall, Texas, with her husband Jon and two children.



Tracey Hull



Tracey Hull is the director of development for Café Momentum, an award-winning nonprofit restaurant located in the heart of downtown Dallas, which offers 12month paid internships created to equip the community's justice-involved youth with life skills, education, medical and mental healthcare and employment opportunities to help them reach their full potential. Before Café Momentum, Hull led development for The Dallas Opera and funded the most successful era in company history including opening the Winspear Opera House, eight world-

premiere operas, funding the Hart Institute for Women Conductors and free public simulcasts. Hull also ran the American Institute of Musical Studies in Graz, Austria.

As an active community partner, she's served on many boards, including executive committee roles for the Housing Crisis Center of Dallas and the Texas Rangers Baseball Club. Hull is a proud Dallas native, resident and graduate of Randolph Macon College in Virginia.

About Texas CASA

Austin-based Texas CASA (Court Appointed Special Advocates) is the statewide organization of 73 local CASA programs that recruit and train volunteers to advocate for children and families in the child protection system. Last year, 9,590 well-trained volunteers served 23,943 children in 219 of the 254 Texas counties. Texas CASA supports the local CASA programs by advocating for effective public policy for children in the child protection system and by providing funding, training and technical assistance to program staff, board and volunteers.

CASA volunteers are everyday people from all walks of life in the child's community who are specially trained to advocate for them. They get to know the child, parents and family, and gather information from everyone involved in their daily life. Volunteers work collaboratively with professionals, family and others to promote the child's best interest in court, school, their foster placement and other settings. CASA volunteers advocate first for reunification when safe and possible, and work to keep children connected to their family and community of origin. They focus on facilitating nurturing relationships for the child and helping to find, engage and strengthen a support network for the child and family.
