Judge Aurora Martinez-Jones



Judge Aurora Martinez Jones is the 126th District Court judge in Travis County and is responsible for the administration of all Travis County Termination of Parental Rights lawsuits filed by the Texas Department of Family and Protective Services. She is the presiding District Judge for the Travis County Family Drug Treatment Court: Parenting in Recovery and of the Crossover Program for Dual Status Youth. She co-founded the Child Welfare Race Equity Collaborative in Texas and is committed to equitable and progressive approaches to supporting the children and families who appear in her court.

Judge Carlos Villalon, Jr.

Judge Carlos Villalon Jr. is appointed as Associate Judge for the Child Protection Court of the Rio Grande Valley West and presides over child welfare cases in both Hidalgo and Starr Counties. He has served as a Commissioner on the Texas Children's Commission and currently serves as Chair on the Commission's Statewide Collaborative on Trauma-Informed Care Implementation Task Force. His court is also a mentor site in the National Council of Juvenile and Family Court Judges' Implementation Sites Model Courts Project and the Child Protection Court Dual Status Pilot.



Judge Delia Gonzales



Judge Delia Gonzales is appointed as the Associate Judge for the Child Protection and Permanency Court in Dallas County. She serves on multiple committees through the Texas Children's Commission and the National Center for Juvenile and Family Court Judges. Recently, she was awarded the Ken Fuller Pro Bono award by the State Bar of Texas for her dedication and leadership to the youth that the Court serves. She has built the fundamentals for the court to assist children who are in the permanent custody of CPS obtain positive permanency, and address wellbeing issues.

Judge Robert R. Hofmann

Judge Rob Hofmann recently began a fourth term as judge of the 452nd Judicial District in five Hill Country counties. In 2021, he was appointed by the Supreme Court of Texas to serve as Senior Jurist in Residence for the Children's Commission. He currently serves as President-Elect for the board of directors of the National Council of Juvenile and Family Court Judges. He has served Texas as judicial representative at several national summits as well as current membership on the National Center for State Courts' Rural Justice Collaborative Advisory Council.



About Texas CASA

Austin-based Texas CASA (Court Appointed Special Advocates) is the statewide organization of 73 local CASA programs that recruit and train volunteers to advocate for children and families in the child protection system. Last year, 9,590 well-trained volunteers served 23,943 children in 219 of the 254 Texas counties. Texas CASA supports the local CASA programs by advocating for effective public policy for children in the child protection system and by providing funding, training and technical assistance to program staff, board and volunteers.

CASA volunteers are everyday people from all walks of life in the child's community who are specially trained to advocate for them. They get to know the child, parents and family, and gather information from everyone involved in their daily life. Volunteers work collaboratively with professionals, family and others to promote the child's best interest in court, school, their foster placement and other settings. CASA volunteers advocate first for reunification when safe and possible, and work to keep children connected to their family and community of origin. They focus on facilitating nurturing relationships for the child and helping to find, engage and strengthen a support network for the child and family.
